RE: NATIONAL TREASURY INSTRUCTION NOTE ON ENHANCING COMPLIANCE MONITORING AND IMPROVING TRANSPARENCY AND ACCOUNTABILITY IN SUPPLY CHAIN MANAGEMENT

Purpose

The purpose of this memo is inform service providers/suppliers who are already registered on NAMC data base, of the new practice not issue by national Treasury regarding compliance monitoring, improving transparency and accountability in supply chain management.

Background

According to practice noted dated 31 May 2011, it requires all suppliers/ service providers to complete the SBD 4 form (Declaration of interest) before NAMC issues the purchase order to a particular supplier. This is done in order to promote economy, efficiency, effectiveness and transparency in the use of state resources; with the key objectives of eliminating waste and corruption in the use of public assets.

It is for this reason that we request all suppliers to complete the attached SBD 4 form and forward it to NAMC, this is also applicable to suppliers whom NAMC has already engaged as from April 2014. It should be noted that the suppliers should updated the SBD forms every year. Please take note that the deadline for this year is 10 July 2014.

Your co-operation in this regard will be highly appreciated.

DECLARATION OF INTEREST

1.  - the legal person on whose behalf the bidding document is signed, has a relationship with persons/a person who are/is involved in the evaluation and or adjudication of the bid(s), or where it is known that such a relationship exists between the person or persons for or on whose behalf the declarant acts and persons who are involved with the evaluation and or adjudication of the bid.

- (e) Parliament.

²"Shareholder" means a person who owns shares in the company and is actively involved in the management of the enterprise or business and exercises control over the enterprise.
