# FOOD BASKET PRICE MONTHLY

## December 2018

*The basket of food products included in this publication is derived from the Income and Expenditure Survey (IES) of 2014/15', compiled by Statistics South Africa (Stats SA). This food basket is to be representative of consumer spending on food and, as a result of the IES 2014/15 release and the CPI base year (2016=100) adjustment, the food basket had since been altered. Cognisance of the above background should be taken when interpreting the data.*

### Highlights

- *Food and non-alcoholic beverage inflation remained at 3.4% during November 2018, year-on-year (y-o-y) as was reported in October 2018, with Headline inflation increasing to 5.2%.*
- *Meat price inflation decelerated to 2.8% (y-o-y) from 4%, with milk, eggs and cheese inflation decreasing by 2% (y-o-y) from 2.9%. Sugary food prices increased to 2.8% (y-o-y), with bread and cereals increasing by 1.3% from a deficit the previous month.*
- *During December 2018 Fuel (93 ULP) prices decreased to R15.01/ℓ from R16.85/ℓ (m-o-m), with 0.05% Diesel at R14.67/ℓ from R16.12/ℓ (m-o-m). Prices decreased by R1.84/ℓ for petrol, and by R1.45/ℓ for diesel, affective early December 2018.*
  - *Compared to November 2017, fuel increased by 23.1% (y-o-y), with private transport increasing 19.2% and average public transport costs up with 6.8% (y-o-y).*
- *In November 2018, the nominal cost of the NAMC's 28-item urban food basket reached R849.69 compared to the R846.60 reported in October 2018, indicating a (m-o-m) percentage increase of 0.4%. When compared to November 2017, an annual (y-o-y) percentage increase of 0.7% was reported.*

## 1. Introduction

The NAMC monitors food prices at retail level and releases regular authoritative reports. The Department of Agriculture, Forestry and Fisheries (DAFF) established the Food Price Monitoring Committee (FPMC) at the NAMC to track and report food price trends in South Africa; to provide explanations of the observed trends and to then advise the department on any possible action that could be taken should national and household food security be threatened. The FPMC was established after the high food price episode of 2000/01 season. The functions of the FPMC were continued by the NAMC after the FPMC completed its work in August 2004. The NAMC issues four quarterly Food Price Monitoring Reports annually and, since 2005, also publishes an annual Food Cost Review, which documents the margins between farm and retail prices of the major food products, amongst other topics. In 2015, the NAMC began releasing a quarterly Farm-to-Retail-Price-Spread (FTRPS) publication, which seeks to provide more insight into the factors driving commodity and food price margins. This publication, the Food Basket Price Monthly Report, came as a result of discussions with industry to keep a more frequent watch on the movements of food prices.

## 2. Overall inflation and food inflation

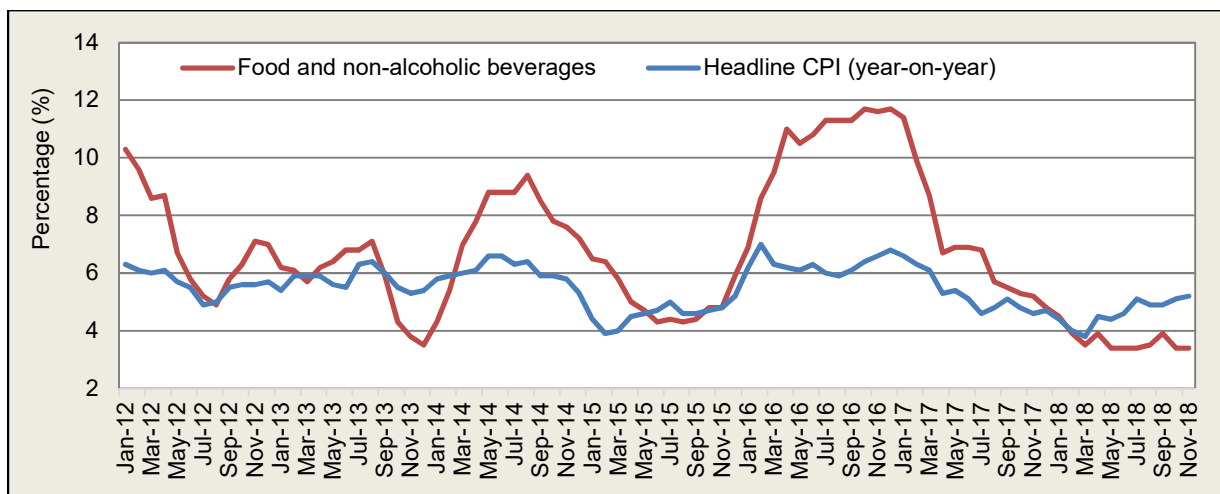


Figure 1: Headline CPI and food and non-alcoholic beverage CPI

The November 2018 Consumer Price Index (CPI) released by Statistics South Africa (Stats SA) indicated that the headline CPI and the food and non-alcoholic beverage price indices reached 5.2% and 3.4%, respectively, compared to the 5.1% and 3.4% reported in October 2018. **Figure 1** show the trends in the headline CPI and food and non-alcoholic beverage inflation rates on a monthly basis, from January 2012 to November 2018.

## 3. Comparison between urban and rural prices: November 2018

**Table 1** compares prices of selected food items in rural and urban areas for November 2018. The food items which showed the largest price differences between urban and rural areas in November 2018 were: sunflower oil (750ml) at a difference of R4.89, Ceylon/black tea (62.5g) at R3.43 difference, and special

maize meal (2.5kg) at a difference of R0.33. This indicates that urban consumers paid more for some of these food items than their rural counterparts. In other cases, however, rural consumers paid more for certain products (e.g. white sugar (2.5kg), peanut butter (400g) and full cream milk – long life (1ℓ), than their urban counterparts.

## 4. The NAMC food basket

This section analyses the nominal cost of a basic 28-item NAMC urban food basket, based on average food price data for the November 2018 vs. November 2017. Composition of the current food basket (as revised in 2017) include: apples (per kg), baked beans – tinned (410g), bananas fresh (per kg), beans – dried (500g), beef mince fresh (per kg), beef offal fresh (per kg), cabbage (per kg), Ceylon/black tea (250g), cheddar cheese (per kg), chicken giblets (per kg), eggs (1.5 dozen), fish (excl. tuna) – tinned (400g), full cream milk – long life (1ℓ), instant coffee (250g), IQF chicken portions (2kg), a loaf of brown bread (700g), a loaf of white bread (700g), margarine brick (500g), onions fresh (per kg), oranges (per kg), peanut butter (400g), polony (per kg), potatoes fresh (per kg), rice (2kg), sugar white (2.5kg), sunflower oil (750mℓ), super maize meal (5kg) and tomatoes fresh (per kg).

In November 2018, the nominal cost of this 28-item NAMC urban food basket reached **R849.69** compared to the **R846.60** reported in October 2018, indicating a m-o-m percentage increase of 0.4%. When compared to November 2017, an annual (y-o-y) percentage increase of 0.7%, was reported.

The 28-item NAMC urban food basket products (in nominal terms) are highlighted in **Table 2**. Products exceeding the South African Reserve Bank's (SARB) upper annual inflation band of 6%, include the following: Ceylon/black tea 250g (6.8%), beef mince – fresh per kg (6.7%), onions – fresh per kg (8.7%), potatoes – fresh per kg (7%) and tomatoes – fresh per kg (17.4%).

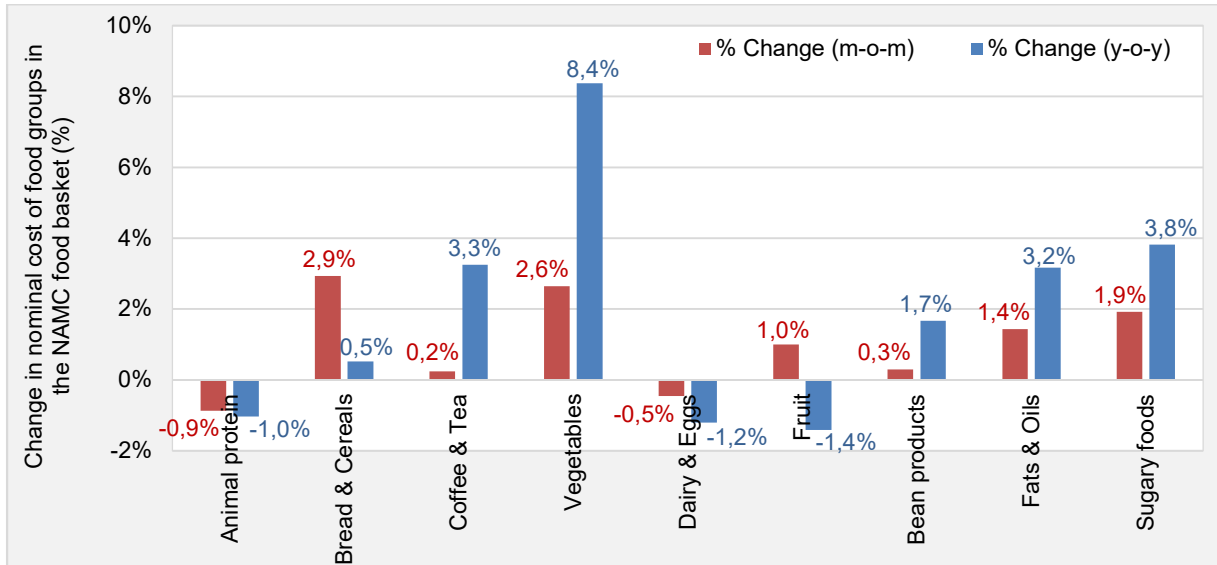

To further explore the impact of inflation on consumers, **Figure 2** presents an illustration of the average nominal cost growth of specific food groups within the 28-item NAMC food basket, comparing the periods November 2018 vs. November 2017 (y-o-y) and November 2018 vs. October 2018 (m-o-m). The following food categories in this basket experienced increased annual inflation: vegetables, sugary foods, coffee & tea, fats & oils, bean products, and bread & cereals.
