

# PRICE MONTHLY August 2019

- **Highlights**
- Food and non-alcoholic beverage inflation eased to 3.4% from 3.7% during July 2019 year-on-year (y-o-y), with Headline inflation decreasing to 4%.
  - o Sugary foods and bread & cereals remain the highest food inflation contributors (y-o-y) with 8.7% and 7.9%, respectively, with meat price inflation 0.2% lower than a year ago.
- Fuel prices increased by 10c/l in August 2019 to reach R15.72/l (93ULP) and R15.92/l (95ULP), respectively. Diesel 500ppm decreased from R14.46/l to R14.33/l (-13c/l).
  - o The driver behind the price changes in August include the international cost of petroleum products (mainly influenced by international oil prices), the

- weakening of the rand/dollar exchange rate, local politics and warnings regarding the economy. o September 2019 fuel prices are predicted to increase by 10-12c/l for petrol, with diesel expected to increase by 15-16c/l. The main reasons include rand weakness after a lengthy period of stability which has added pressure to the fuel price and left SA fuel users at the mercy of international oil markets.
- During July 2019, the nominal cost of the NAMC's 28-item urban food basket amounted to R870.47 compared to the R873.75 reported during June 2019, resulting in a monthly percentage decline of 0.4%. When compared to July 2018, an annual (y-o-y) percentage increase of 3% was reported.



### **Introduction**

The NAMC monitors food prices at retail level and releases regular authoritative reports. The Department of Agriculture, Forestry and Fisheries (DAFF) established the Food Price Monitoring Committee (FPMC) at the NAMC to track and report food price trends in South Africa; to provide explanations of the observed trends and to then advise the Department on any possible action that could be taken should national and household food security be threatened. The FPMC was established after the high food price episode of 2000/01 season. The functions of the FPMC were continued by the NAMC after the FPMC completed its work in August 2004. The NAMC issues four quarterly Food Price Monitoring Reports annually and, since 2005, also publishes an annual Food Cost Review, which documents the margins between farm and retail prices of the major food products, amongst other topics. In 2015, the NAMC began releasing

a quarterly Farm-to-Retail-Price-Spread (FTRPS) publication, which seeks to provide more insight into the factors driving commodity and food price margins. This publication, the Food Basket Price Monthly Report, came as a result of discussions with industry to keep a more frequent watch on the movements of food prices.

# Overall inflation and food inflation




Figure 1: Headline CPI and food and non-alcoholic beverage CPI

The July 2019 Consumer Price Index (CPI) released by Statistics South Africa (Stats SA) indicated that the headline CPI and the food and non-alcoholic beverage price indices reached 4% and 3.4% (y-o-y), respectively, from 4.5% and 3.7% reported during June 2019. Figure 1 show the trends in the headline CPI and food and non-alcoholic beverage inflation rates on a monthly basis, from January 2012 to July 2019.

Comparison between urban and rural prices July 2019

Table 1 compares prices of selected food items in rural and urban areas for July 2019. The food items which showed the largest price differences between urban and rural areas in July 2019 were: sunflower oil (750ml) at a difference of R3.70, Ceylon/black tea (62.5g) at R3.17 difference, and super maize meal (2.5kg) at a difference of R1.29. This indicates that urban consumers pay R0.34 more, on average, for some of these food items. In other cases, however, rural consumers paid more for certain products (white sugar (2.5kg), margarine spread (500g), and peanut butter (400g)), than their urban counterparts.

## The NAMC food basket

This section analyses the nominal cost of a basic 28item NAMC urban food basket, based on average food price data for the July 2019 vs. July 2018. Composition of the current food basket (as revised in 2017) include: apples (per kg), baked beans tinned (410g), bananas fresh (per kg), beans - dried (500g), beef mince fresh (per kg), beef offal fresh (per kg), cabbage (per kg), Ceylon/black tea (250g), cheddar cheese (per kg), chicken giblets (per kg), eggs (1.5 dozen), fish (excl. tuna) – tinned (400g), full cream milk – long life (11), instant coffee (250g), IQF chicken portions (2kg), a loaf of brown bread (700g), a loaf of white bread (700g), margarine brick (500g), onions fresh (per kg), oranges (per kg), peanut butter (400g), polony (per kg), potatoes fresh (per kg), rice (2kg), sugar white (2.5kg), sunflower oil (750ml), super maize meal (5kg) and tomatoes fresh (per kg).

During July 2019, the nominal cost of the NAMC's 28-item urban food basket amounted to R870.47 compared to the R873.75 reported during June 2019, resulting in a monthly percentage decrease of 0.4%. When compared to July 2018, an annual (y-o-y) percentage increase of 3% was reported.

The 28-item NAMC urban food basket products (in nominal terms) are highlighted in Table 2. Products exceeding the South African Reserve Bank's (SARB) upper annual inflation band of 6%, include the following: baked beans - tinned 410g (8.6%), peanut butter 400g (7.9%), Ceylon/black tea 250g (7.9%), full cream milk - long life 1ℓ (6.7%), apples – fresh per kg (13.8%), bananas – fresh per kg (22.8%), fish (excl. tuna) - tinned 400g (6.2%), loaf of brown bread 700g (11.3%), loaf of white bread 700g (6.8%), super maize meal 5kg (16.7%), cabbage – fresh per kg (6.8%), and white sugar 2.5kg (11.1%).




Figure 2: Nominal cost growth of specific food groups within the NAMC's 28-item food basket, comparing July 2019 vs. July 2018 and July 2019 vs. June 2019

To further explore the impact of inflation on consumers, Figure 2 presents an illustration of the average nominal cost growth of specific food groups within the NAMC's 28-item food basket, comparing the periods July 2019 vs. July 2018 (y-o-y) and July 2019 vs. June 2019 (m-o-m). Food categories in this 28-item food basket experiencing the highest annual inflation includes fruit, sugary foods, and bread & cereals.
